#### 2024-25 Quality, Currency, Availability of Textbooks and Other Instructional Materials

The school district held a public hearing on September 12th, 2023, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

Our school has strong parent support. We welcome parents to serve on the school site council and volunteer at our school. Our opening day packet and school handbook give more information about how parents can get involved. We are proud of how our parents actively support their children at Pleasant View Elementary. The district has partnered with Save the Children to offer the Early Steps to School Success program providing parents with early child development strategies 0-5. In addition, the district provides the Vroom program with child-parent groups and monthly parent education sessions. The active PTO organizes activities, including the fall carnival, and fall and spring book fairs.
